1½ MILES. (224) Running of THE BELMONT. Purse \$500,000 Added. Grade I 3-year-olds. By subscription of \$600 each to accompany the nomination if made on or before January 21, or \$6,000 if made on or before April 1. \$5,000 to pass the entry box, \$5,000 to start with \$500,000 added. At any time prior to the closing time of entries, horses may be nominated to The Belmont Stakes upon payment of a supplementary fee of \$50,000 to The New York Racing Association Inc. All supplementary fees will be included in the purse distribution. Horses nominated by payment of a supplementary fee (supplemental nominees) will not be allowed to enter if the maximum number of starters has otherwise been reached prior to the time of closing. If the number of supplemental nominees exceeds the number of available starting positions at closing, the conditions of each respective race shall be applied to determine which supplemental nominees will be allowed to start in such race. All nominees, supplemental or otherwise, will be required to pay entry and starting fees. The added money and all fees to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Weights: Colts and geldings, 126 lbs. Fillies, 121 lbs. Starters to be named at the closing time of entries. The Belmont field will be limited to sixteen (16) starters. In the event more than 16 entries pass through the entry box at the closing, the starters will be determined at the closing with 50% of the field (8 starters) given preference by accumulating the highest earnings in Graded Stakes (lifetime), including all money paid for performance in such Graded Stakes. The next (5) starters (approximately 30%) will be determined by accumulating the highest earnings (lifetime) in all races except restricted races (i.e., any stake containing eligibility conditions other than sex and age). The remaining 3 starters (approximately 20%) shall be determined by accumulating the highest earnings (lifetime) in all races. Should this preference produce any ties, the additional starter(s) shall be determined by lot. If the rules described result in the exclusion of any horse, the \$5,000 entry fee will be refunded to the owner of said horse. The winning owner will be presented with the August Belmont Memorial Cup to be retained for one year, as well as a trophy for permanent possession and trophies will be presented to the winning trainer and jockey. Closed June 8, with 317 nominations and 7 late nominations.

THUNDER GULCH away in good order, remained in the three or four path while allowed to follow the leaders into the backstretch, moved up outside STAR STANDARD racing into the far turn, caught that one entering the stretch, and proved clearly best. STAR STANDARD angled to the inside after breaking alertly, made the pace into the backstretch while saving ground, commenced bearing out midway along the backstretch, was still narrowly in front while continuing to get out leaving the far turn and bested the others while still drifting. CITADEED, checked along the inside on the first turn, raced within easy striking distance to far turn, came out to make a mild bid but was finished entering the stretch. KNOCKADON, well placed through the first six furlongs, moved up inside horses midway of the far turn but lacked a late response. PANABRASS, bobbed slightly after the start, raced six wide into the backstretch, moved inside at the far turn but failed to seriously menace. OFF'N'AWAY, fractious behind the gate, broke slowly, then lacked room along the inside at the first turn, came out four wide while advancing on the far turn, then continued wide while tiring. AVE'S FLAG failed to be a serious factor. COMPOSER, well placed while between horses into the backstretch, made a run while racing well out from the rail nearing the far turn, then flattened out. COLONIAL SECRETARY was finished soon after going a half and raced very wide late. IS SVEIKATAS, checked between horses on the first turn, was finished after going a half. WILD SYN was prompting the pace between horses when both were some as STAR STANDARD bore out midway along the backstretch, held on well for a mile, then had nothing left.
